Sample Matters

- Karyl and shareholder Chris Cole obtained summary judgment in the Massachusetts Federal District Court in favor of their client, in an action in which the client's former General Counsel sued alleging that the company had failed to pay over \$1,500,000 in severance benefits. *Bukuras v. Mueller Group, LLC*, 2008 WL 3978210 (D. Ma. 2008). The judgment was affirmed on appeal by the First Circuit Court of Appeals. *Bukuras v. Mueller Group, LLC*, 592 F.3d 255 (1st Cir. 2010).
